





Any urgent decision of the Board of Trustees may be finalised by circulation of papers concerning the subject among all the members of the Board of Trustees.


10. The Trustees shall have and may exercise all or any of the following powers that may be considered necessary/desirable for the trust:



- c) To receive donations and endowments from any person including firms, companies, charities or other trusts or funds for the objects of the trust on such terms and conditions as may be accepted by the trustees.
- d) To invest the donations received in any property whether movable or immovable as approved by the provisions of section 13(1)(d) read with section 11(5) of the Income Tax Act, 1961.
- e) To deal with, sell, mortgage, charge, lease, hire, invest, transfer investments, open bank accounts and generally deal with Trust Fund or any part thereof as the Board of Trustees may consider necessary or desirable.
- f) To institute and conduct or defend and legal or other proceedings involving the trust and to engage counsel or attorney and to give them such vakalats or power of attorney as may be necessary.

- g) To frame rules and bye-laws for the conduct of the business of the trust and of its transactions.
- h) Banking accounts shall be opened for the Trust and in the name of the Units of the Trust with Nationalized or Scheduled Banks and shall be operated by the Chairman and one of the trustee duly authorized by the Board of trustees on E or S basis.
- i) The funds of the trust shall be invested only in accordance with the provisions of section 13(1)(d) read with the section 11(5) of the Income Tax act, 1961.
- j) All monies including the main corpus of the trust and of accumulating and receipts of this trust shall be held only in the name of this trust and not in any individual name/names of the trustees.
- k) The accounts of the trust shall be maintained properly and shall be closed on the 31st March of every year.

- l) The accounts of the trust shall be audited every year by a Chartered Accountant.
- m) The net income arising out of the trust properties whether movable/immovable after meeting the necessary expenses shall be utilized only for the above said purposes, in India alone.
- n) The trust shall not carry on any activity outside India.
- o) The trust shall not carry on activity with the intention to make a profit.
- p) The income of the trust shall be solely utilised towards the objects of the trust and no portion of the income or fund shall be utilised for payment to the trustees by way of profit, interest, dividend or any other head.
- q) The trustees shall be entitled to appoint such staff for administering the trust properties on such terms as they may decide and shall have the power to dismiss the persons so appointed with the direction of the chairman of the trust.

- r) the Board of Trustees may appoint committees or sub-committees for such periods and on such terms as it deems fit and dissolve any of them.
- s) The chairman or any trustee shall have power to issue receipts, sanction expenses, execute any documents, make any compromise, negotiate any business or service activity in favour of the Trust.
- t) The trustees shall be entitled to frame, modify and amend the rules for the purpose of administering the trust in a more beneficial manner but they do not alter the basic characters/objects of the Trust.
- u) In the event of trust being dissolved or wound up, the assets of the trust shall be transferred to any other trust of charitable nature.
- v) Any amendment to the object clauses of the deed of Trust, affecting the applicability of direct tax laws, shall be carried out only with the prior approval of the Commissioner of Income Tax having jurisdiction, if grant of Registration u/s.12AA (b) of the Income Tax Act, 1961 obtained for the Trust.


